- Repr_EU shall not be liable for any failure of delay in delivery due to any causes beyond Repr_EU's reasonable control, including but not limited to, acts of nature, acts of governments, international unrest, fires and floods.

Authorised Representative Status

• The The Ptolemaic Press hereby appoints Repr_EU as its Authorised representative in the Area.

Authorised Representative's Duties and Responsibilities

- **Confidentiality;** Repr_EU keeps The Ptolemaic Press files confidential and only share them with European Competent Authorities.
- **Forward Copies;** Repr_EU will forward to The Ptolemaic Press copies of any written requests to the extent that they contain information relating to The Ptolemaic Press and/or the products covered by this agreement.
